- To create good practice transfer platform for exchange of know-how in preparation and implementation of strategies toward carbon neutrality
- To improve transboundary, cross-sectoral and inter-policylevel cooperation with ALPSTAR Policy Board and Alpine Convention.
- To promote integrative and participatory approach in development of cross-sectoral strategies
- To empower local and regional administrative actors and planners to become facilitators of change
- To encourage pooling, transfer and implementation of innovative and efficient good practices from and to other Alpine regions and beyond.





- Good practice transfer platform will be established and ready for use by network of Alpine regions.
- Through face to face exchange approach (study visits, seminars, workshops) capacity of 1500 stakeholders will be increased
- Till project end at least 60 good practice measures will be available as a source of knowledge for good practice transfer and implementation.
- Practical guidelines in preparation and implementation of cross-sectoral strategies and action plans toward carbon neutrality available for use by regions.





- One cross-sectoral strategy or action plan toward carbon neutrality per each pilot region agreed among stakeholders and start of its implementation (12 altogether).
- Implementation start of one good practice measure toward carbon neutrality per pilot region (12 altogether).
- ALPSTAR Policy Board appointed and close cooperation with key policy actors on level of Alps established and continued.
- Recommendations prepared for Policy Board to be used in policies on national, Alpine and EU level. Recommendations of
- Policy Board used in pilot regions' strategic documents assuring consistency with policies.
